### CANCELLATION POLICY

BTSA trip prices are based on group rates reserved in advance, thus a cancellation affects all the trip expenses.  
If the trip is cancelled by BTSA for any reason, refund is 100%, including your deposit.

**If you need to cancel, your \$500 deposit may be applied to another adventure at a later date, within five years.** Unused deposits are donated to community projects in the countries where BTSA operates.

Cancellation 59 days or more before departure, refund is 50%, minus \$500 non-refundable deposit.

Cancellation 30-58 days before departure, refund is 25%, minus \$500 non-refundable deposit.

No refund for cancellation less than 30 days before departure, unless a replacement participant is found.

\*Trip Insurance is mandatory on BTSA trips. Reasonable policies are offered by Allianz, Access America or Travel Guard.

BTSA reserves the right to decline to accept or retain any person whose health or general conduct impedes the operation of services to the detriment of other trip participants or the local population. BTSA reserves the right to remove from a trip, at his or her own expense and without any refund, any person it judges to be incapable of meeting the rigors and requirements of participating in the activities, or who it determines detracts from the enjoyment of the trip by others. BTSA reserves the right to make route, hotel, itinerary, leader changes and trip modifications as necessary or desirable to improve the trip quality and/or to accommodate the safety, comfort and well-being of guests.

### IMPORTANT:

Trips to the Andes involve high altitudes. Trips to West Africa and Asia involve the risk of malaria, and several other maladies. There are malaria prevention medications [not needed for BTSA Peru/Bolivia trips], and also medicines to help with altitude adjustment in the Andes. We request that everyone who signs up to join a Behind the Scenes Adventure talk to his or her health practitioner about these and other health issues. You may also consult the US Government website at [www.cdc.gov](http://www.cdc.gov) for current health information for your destination. Your Trip Packet contains further suggestions for keeping yourself healthy and safe.

### RESPONSIBILITY

While we at Behind the Scenes Adventures take the utmost care to assure the trip participants' safety and well-being, the responsibility of BTSA and operators Cheick and Cynthia LeCount Samaké and others directly employed is limited. BTSA acts only as agents for the trip participant in regard to all travel of all varieties, whether by bus, van, train, taxi, boat, aircraft, pirogue, canoe, camel or other conveyance, and as such, assumes no liability for direct or indirect or incidental damage, bodily injury, death, delay, inconvenience, or other problems which may be caused either through acts of nature/God, fire, breakdown of machinery or equipment, or acts of government or other authorities, wars, declared or undeclared; hostilities, riots, civil unrest or disturbances, strikes, theft, acts of terrorism, sickness or epidemics, allergic reactions, rabid animals, Customs regulations, changes in public transportation schedules, or from any other causes beyond the control of BTSA.

Behind the Scenes Adventures shall not be liable for expenses such as additional hotel nights and meals not specified in the trip itinerary, but which may be required to get to or from a trip starting or ending point; expenses due to the delay of a trip for any reason (e.g., cancelled flights, inclement weather, landslides, flooding, sickness, etc.); expenses involved in recovering luggage lost by airlines, belongings stolen or left behind on a trip, or in shipping purchases home from abroad.

### RELEASE OF LIABILITY

I agree to follow all written and verbal rules of safety or otherwise presented to me by BTSA or the trip leaders.
